PRESIDENT'S REPORT

2019 Accomplishments

Construction of the new Mont Pleasant Branch Library.

- Carpet and window cleaning schedule established. New computer tables and chairs for Central, along with electrical upgrades. Additional security cameras installed at branches.
- Re-dedication of the Central Library as the Honorable Karen B. Johnson Library in September.
- Installation of the William Seward and Harriet Tubman statue at the Central Library in May.
- Planning Committee, chaired by Cheryl Cufari, completed a summary of the 2016-2019 Long Range Plan of Service and finalized the 2020-2023 Long Range Plan of Service.
- Heather Gray became new chair of the Branch Committee. Representatives will continue to share feedback about branch concerns such as circulation, safety, staffing and programming.
- The Library Board welcomed two new trustees, Portia Alston and Steven McCutcheon.
- In October, Sharon Jordan received a Community Service award from the Schenectady County Democratic Committee at its annual JFK Awards Dinner, commemorating her dedicated service to the Schenectady County Public Library.
- The advocacy of the trustees, and the leadership of the Finance Committee, chaired by Joe
 Landry, resulted in the timely 2020 budget submission to the County. The library was approved
 for two additional full-time positions, an increase in security and maintenance cleaning services,
 and two capital improvement projects in the 2020 SCPL budget that was passed by the County
 Legislature.

- Carolyn Morin, Supervisor at the Glenville Branch Library, is retiring on January 30, 2020. Leah
 LaFera, Adult Programming Librarian is resigning her position as of February 4 to pursue her
 business, Sweet Spriq, full-time.

SAFETY AND SECURITY COMMITTEE

- The Safety and Security Committee met on January 9, 2020.
- Security issues at the Bornt and Mont Pleasant Branch Libraries were discussed. Plans for improvement include working on stable staffing, additional coverage from the Sheriff's Department, additional security cameras on the outside and adding a 30-day retention, and adjusting cameras to get face shots.
- Niskayuna Plans to fix lamppost, replace the glass to clear glass and change to LED lights.
- Central Plans to add a doorbell near the glass doors that will ring at either reference or
 circulation desk. The incidents involving young boys riding bmx bikes recklessly through the
 parking lot and on the loading dock was discussed. Possible solutions are to contact the parents
 and add pegs to the metal platform that they use for jumping.
- Staff should contact Karen Bradley or Beth DeMidio immediately for the following:
 - Weather related issues at all branches involving icy pavement, walkways, and leakage from heavy rain.
 - Health and safety items, including expiration dates on Narcan, blood borne pathogen supplies, Defibrillator supplies along with sharp containers that are full and first aid kit replenishment.
- Staff training is needed, especially in the area of dealing with disorderly and disruptive patrons.
